It is the argument of cooperators that cooperatives are indeed already included in the term 'associations', but given that courts have held otherwise, this amendment appears necessary.*

*In Part IV, in Article 39(c), after the semi-colon at the end, the following words could be added: 'to this end, among other measures, the State shall secure that citizens, women and men, can voluntarily form cooperatives, that is, jointly owned, democratically controlled, autonomous enterprises, to meet their common economic needs;'*"
